And then the Spokane Hamfest/Washington State Convention......the best ever, thanks to the 8 participating clubs.

Kamiak Butte System Refurbished, 6-M Repeater, Battery Backup

Local KBARA members refurbished the Kamiak Butte voice system Saturday, October 10. Jim of K7LL, the Whitman County Emergency Coordinator, and Dan of K7MM and VU3MMW, Assistant EC made the plans to repackage the 33 year-old system into a new rack and add a 6-m repeater for better emergency coverage, especially in the Snake River breaks.

Jay of N7ZUF, Ray of KE7WOE, and Tom of AD7ZZ arrived with Jim and Dan on the cold, below-freezing Saturday morning. Dan was up the tower with Jay and Ray as ground crew. Jay and Ray were thankful for their hardhats because Dan's fingers were so cold that he kept dropping his tower knife! Dan removed some unused county antennas and installed an interim 6-m antenna as well as a new 440.975 MHz digital packet station antenna. (Previously the UHF packet node was diplexed on the 2-m antenna.) Dan also repaired the link antenna mount, changed from lossy RG-8 coax to Andrew ½-in. hardline, and added a Dacron-rope guy pulling up.

Jim and Tom gutted the old repeater cabinet. They installed the one-year old 146.740 MHz 2-m repeater, the new 223-MHz

link radio with true-FM modulator and audio output processing, and the new 53.750 MHz 6-m repeater. They rearranged the 2-m duplexer and circulator/cavity, and the 223-MHz circulator/cavity into the new rack. The 6-m duplexer and 7-foot tall bandpass cavity stand next to the new cabinet.

Near sundown Dan came down the tower. Jim and Tom had to leave and turned over the project to Dan, Jay, and Ray. Jay and Ray worked on perfecting the new battery backup charging and dc power distribution rack-mount panel, dc fusing and cabling, and testing. Dan made cables to finish connecting all the new cable routes. Working through most of the night the KBARA hams got the system running just before the 7 a.m. Sunday Road Runner net.

Smokin' Antenna

This is an update of the Summer, 2009 newsletter article. The dual-band (80/160 Meter) antenna works great! I began using the antenna seriously in late September, 2009 when the low bands became lively again & the summer QRN noise lowered. I have been using it almost exclusively on 160 meters since I found that band most challenging. In less than a month of use on 160 meters, I have worked Japan, Australia, Chatam Island, Conway Reef, Fiji, New Zealand, Hawaii, Alaska, USA, Canada, Mexico, Argentina, Finland, Market Reef, Sweden, Asiatic Russia, European Russia, Slovokia, Latvia, Lithuania, Hungary, England, & Estonia.

Due to the antenna linear loading element, there is 60 feet of wire that is fed before being attached to the base of the 70 foot tower. Therefore, the voltage is high at the base of the antenna (unlike a 1/4 wavelength antenna fed directly at the base). I noticed that when I watered the area underneath the antenna, the SWR would go down. I discovered that this was due to the signal arcing to the ground from the base of the antenna. I keyed down the transmitter, went outside, & discovered smoke & steam coming from underneath the antenna. The piece of plastic separating the base of the tower & the ground was too thin & the RF would arc through to the ground. Got rid of a lot of gofers I would guess! The problem was corrected by putting a one inch thick piece of plastic between the antenna & the ground. Thank You Mark, K7HPT, for the plastic. So you now understand why this is called a Smoking Smokin' Antenna!

KBARA Membership / Support Information

The KBARA repeater system consists of several privately owned linked Amateur Radio repeaters. It covers an area from northeastern Washington to northeastern Oregon, and from western Montana to central Washington. The KBARA system is also part of the Evergreen Intertie, an interconnected group of repeaters located in western Washington and Oregon. The primary purpose of the KBARA repeaters is to provide a means for emergency communications within the above areas, and secondarily for routine radio traffic. It makes possible a single system of mobile communications coverage, extending the limited range provided by any single repeater operation.

The KBARA FM repeaters operate in the VHF bands and are linked by UHF radios. The repeaters' frequencies, call signs, locations and owners are as follows:
